Recent Events

- Petitions to the Commission at the April Commission Meeting
 - Wyoming Untrapped and WY Trap FREE-Mont County
 - Asked Commission to open Chapter 4 prior to 2022
- Department Committee Formed
 - Develop and implement a deliberate and information-based process to inform the Commission on trapping related matters identified during the April 2020 meeting. The presentation should also include past efforts by the Department and comments, concerns and opportunities learned from contacts with a broad group of current stakeholders.
 - Carefully consider all relevant information and compile meaningful information to help inform the Commission as they further deliberate any potential action pertaining to Chapter 4.

Definitions

"Furbearing animal" means badger, beaver, bobcat, marten, mink, muskrat or weasel.

"Predatory animal" means coyote, jackrabbit, porcupine, raccoon, red fox, skunk or stray cat. "Predatory animal" also means gray wolf located outside the Wolf Trophy Game Management Area and Seasonal Wolf Trophy Game Management Area as described in W.S. § 23-1-101 (a) (xii) (B) (l) and (II).

Wyoming Constitution

Article 1, Section 38 (2012)

"The opportunity to fish, hunt and trap wildlife is a heritage that shall forever be preserved to the individual citizens of the state, subject to regulation as prescribed by law, and does not create a right to trespass on private property, diminish other private rights or alter the duty of the state to manage wildlife."

- W.S. 23-2-303, review of changes 2001-present
 - o **2001**
 - Added snares to tagging requirement
 - Allows for trap ID # to be issued by Department and used instead of name/address
 - Added language making it illegal to set traps/snares within 30 ft of exposed bait
 > 5lbs
 - Added definition of exposed bait
 - Added snare requirements
 - 295lb breakaway
 - Maximum 12 inch loop diameter
 - 72 hour check period excluding snares and quick kill body traps
 - Wildlife caught shall be removed upon discovery

o 2004

 Made tampering/removing a legal trap/snare or releasing furbearers/predators from legal traps/snares illegal.

2009 - Department LD1 Project

- Added language allowing the Commission to regulate trap/snare requirements to establish specifications for snares, breakaway weights, location of breakaway devices, snare loop size and anchors for trapping and snaring of furbearers and predatory animals. (requires consultation with other affected entities)
- Removed all statutory language related to above
- Added once per week check period for snares and quick kill body traps

- Commission Regulation CH 4, 1994 present
 - 1994-97
 - Areas closed to the trapping of all species
 - Grand Teton NP
 - Closed to all trapping
 - National ELk Refuge
 - Closed to all trapping
 - JDR Memorial Parkway
 - Leghold traps and snares prohibited
 - Red Canyon Elk Winter Range
 - Closed to all trapping December 1-April 30
 - Medicine Bow River from Ranger Station to Bow River Campground
 - Closed to all trapping

1997-98

- Changed from trapping of all species closures to closed to furbearer trapping/closed to all legholds and snares and removed Red Canyon and Medicine Bow River from any type of closure.
- Closed to furbearer trapping
 - Grand Teton NP
 - National Elk Refuge
- Added Rawhide, Springer, and Table Mountain WHMAs to areas closed to furbearer trapping from October 1-January 31.
- Closed to all leghold traps and snares
 - JDR Memorial Parkway

o **2002-03**

- "Quick Kill Body Grip Trap" and "Trap Identification Number" added to definitions and the word "snare" added to the definition of Trapping.
- Added Bighorn Canyon National Recreation Area to areas closed to use of leghold traps and snares
- Added trap ID# use and requirements to obtain a trap ID#

- o 2006-08
 - All areas previously listed as closed to use of leghold traps and snares moved to areas closed to the taking of furbearing animals
- o 2009-12
 - LD1 Project
 - Added snare requirements for the taking of furbearers and predatory animals to regulation
 - Breakaway weights
 - Location of breakaway devices
 - Snare loop size
 - Anchors for trapping and snaring of furbearers and predatory animals.
 - Added once/week check period requirement for snares and quick kill body traps

- o 2012-14
 - "Live Trap" added to definitions
 - Reformatted snare requirements and check period section
- o 2016-19
 - Added definitions of "pet" and "tamper"
 - 330 conibear removed from public land use and must be partially submerged
 - Addition of Section 11 (e) to allow the release of pets and livestock from traps
- o 2019-current
 - 12 defined terms
 - Removal of some LQ Beaver trapping areas and addition of some areas closed to beaver trapping

- License Sales
 - 2001- 1097 licenses sold
 - 34 Nonresident
 - 2010- 1869 licenses sold
 - 43 Nonresident
 - 2019- 2498 licenses sold
 - 47 Nonresident

- Furbearers harvested 2010 / 2019
 - o Totals 10,788 / 7,404
 - Trapped 9,861 / 6,682
 - Snared 179 / 205
 - Firearm 748 / 517



Surrounding State Regulations CO, ID, MT, ND, NE, SD, UT

- Trapper education required: CO & ID (MT for wolves only)
- **Setbacks:** CO, ID, MT, NE distance varies 10 1,000 feet
 - Trails, roads/highways, dwellings, feedlots, livestock road crossings, campgrounds/rec. sites
- Closures for recreation: CO, ID, MT, NE, SD, WY
 - Public ski area, residential rec. area, state game refuges/wildlife areas, some bird hunting areas
- Trap signs recommended ID, CO
- Trap checks: CO, NE 24 hrs; SD east 48 hrs; ID, SD west 72 hrs; (WY- 72 hrs, leghold and live traps, Once/week snares and quick-kill traps); UT 48 hrs non-lethal and 96 hrs lethal trap check; MT 48 hours recommended (required for bobcat sets); ND none

Surrounding State Regulations

CO, ID, MT, ND, NE, SD, UT

- Report non-targets required:
 - MT All non-targets
 - UT All protected species
 - CO, ID, ND, SD Dead furbearers/wildlife/protected species
 - o NE None
 - o WY Injured or dead game animals/raptors/furbearers out of season


• Trap types allowed:

- ID, MT, ND, NE, UT, WY- All types with some restrictions to placement/types of quick kill body traps, lock type/breakaway for snares
- CO Only live traps, footholds on private lands with strict conditions
- SD Spring-powered snares banned

Trapping Violations

- 2006-2020
 - 837 violations (390 citations, 341 warnings, 106 unknown suspects)
 - Total Fines \$78,931
 - Total Restitution \$2,541
 - Total License Suspensions 85 years
- Other info (2006-2020)
 - Dogs chasing deer- 465 violations (233 citations, 205 warnings, 27 unknown suspect)
 - Unlawful tampering or removal of trap or snare 42 violations
 (19 citations, 11 warnings, 12 unknown suspect)
 - Unlawful release/removal of furbearer/predator from trap or snare - 8 violations (2 citations, 4 warnings, 2 unknown)




Stakeholder Contact Summary
